

Appendix 001 Tree Survey Plan

1.0 INTRODUCTION

1.1 This report was commissioned by Tollesbury Parish Council in relation to the condition of the trees on the green at Hasler Road, Tollesbury. The report records trees over 75mm at 1.5m above ground level that are relevant to the safe use of the public open space. The position of the trees on the site is illustrated at **Appendix 001** on the site plan and information about the tree stock and its current condition is given. It will assist the management process by discussing the need for works to the existing tree stock.

2.0 SITE VISIT

- 2.1 The site visit was undertaken on 18.11.2022. The trees were surveyed visually, externally and from ground level only. No samples or internal decay detection readings were taken for further analysis. All dimensions have been measured unless stated otherwise. Weather conditions at the time of the survey were dry and overcast.
- An existing site layout plan was used as a base to plot the trees. No accurate survey of the tree locations was available, and the location plan should be cross referenced with the schedule tables to identify particular specimens accurately.

3.0 TREE SURVEY DATA

In accordance with BS 5837:2012, the characteristics of trees over 75mm stem diameter measured at 1.5m above ground level have been recorded and they have been categorised in accordance with Table 1 of BS5837: 2012. The following tree data tables should be read in conjunction with the annotated site plan shown at **Appendix 001** and the key on page 6.

4.0 Tree Data Tables

The data contained within the following Tables should be read in conjunction with the notes below, the map at **Appendix 1** and the following discussion at Section 7.

Tree Number: corresponds to the plan attached at Appendix 1.

Height: Estimated

Age Class

Y = Young tree

SM = Semi mature (Tree having attained 1/3 to 2/3 full stature and 1/3 to ½ estimated lifespan)

EM = Early Mature (Tree at ¾ to virtually full size)

M = Mature

OM = Over mature/Senescent.

Priority for recommended works

H – High - urgent work to be carried out within the next 6 months

M - Medium - work to be carried out within the next 12 months

L - Long term - work to be carried out within 24 months of the report

Important notes

Recommendations for management have been made with regard to good arboricultural practice as well as current British Standards and guidance notes. Recommendations for management are current and the urgent works should ideally be carried out within the next 6 months. It should be recognized that trees are dynamic structures that can never be completely predictable and may become unstable or partially unstable even in average weather conditions. Stability or safety cannot be construed from any lack of recommended works. As trees are constantly changing, dynamic structures, comments regarding the health and safety of the trees are correct and valid at time of inspection.

5.0 Discussion

5.1 Tree Quality Assessment

Seven trees have been surveyed for safety purposes and categorised according to their condition. They are coloured on the plan attached at **Appendix 001** to indicate priority need for works. The colours are explained in the key of the plan. Table 1 indicates whether the tree needs work urgently, within 12 months or 24months.

High Category Trees



Photos 01 & 02. T1 is a field maple growing in the south-west corner of the Site next to No.8 Hasler Road. The tree appears to have lost a large branch in the past and this has created a cavity which has partially grown over. The general condition of the tree is good, but the point of branch union should be monitored for signs of decay and movement.

The ground surrounding the tree has been compacted and it would benefit from being mulched up to a radius of 1.5m from the stem. This would also reduce the need for mowing machinery to get too close to the stem and causing damage.





Photo 03 & 04. T4 is another Field Maple growing on the eastern edge of the green next to the path through to Sceptre Close. The tree is multi stemmed with some damage to the stem, but this is healing over. The tree appears to have been used to climb and play on judging by the wear and therefore its general condition should be monitored to ensure that any safety risk is minimised.





Photos 05 & 06. T5 is in good condition and is a well-balanced Alder growing on the eastern edge of the Site. The path through to Sceptre Close runs beneath the canopy. Due to the degree of risk associated with its failure so close to homes and a public open space, the tree should be subject to an annual visual check to monitor general health. Any signs of stress, damage or die-back should be reported and checked.





Photos 07 & 08. Growing on the north-west edge of the green, T7 is a Prunus sp. There has been considerable damage to the stem and there is also an included bark stem union which is a point of weakness. The tree is relatively small and poses a limited risk, but the branch union should be monitored for signs of excessive movement.

Medium Category Trees

Trees which fall into the medium category, do not require urgent work, but they should be carefully reviewed on an annual basis to ensure that they do not decay to the extent that they pose a risk to the public.





Photo 09 &10. T2 is a mature Sycamore a large horizontal wound on the main stem. Whilst the general form is good, there are some signs of die-back in the crown and the general health should be monitored.



Photo 11 &12. T3 is a mature Sycamore growing in the south-east corner of the Site. There has been some pruning work to the branch overhanging the adjacent garden. Photo 12 (right) shows T3 growing in the corner of the open space, where it is suffering due to competition for light and space.



Photo 13 &14. Tó is growing in the north-east corner of the green and next to a streetlight. The tree has two main leaders and a large, included bark union. The crown has been subjected to a reduction, which has initiated a stress response of vigorous branch end growth. The branches which are affecting the street lamp should be pruned back lightly to ensure that the path is properly lit. The general vigour and health of the tree should be monitored regularly (every 6 months) in case of any deterioration.

In most cases, of those in the medium category it is advised that they are checked annually (unless stated) for any signs of decay or defects that may pose a safety risk.

Low Category Trees

The trees identified as being in the low category do not require any imminent work. They are all in good health and they would benefit from being checked every year (or every other as noted in table 1) to make sure that damage has not occurred and that decay has not set in.

6.0 Conclusions

- When undertaking a review of the health of the trees in a public space the main concerns are safety of the end user and the level of risk. The works identified in this report are recommendations and highlight the specimens at greatest risk of failure should work not be undertaken.
- 6.2 It should be noted that trees are living things subject to change and the effects of their environment. It may be that extreme weather (drought or storms) result in unanticipated damage that renders them unsafe. If there are concerns or obvious changes to the health of the tree a professional Arboriculturalist should be consulted and the tree inspected.
- 6.3 The open green area off Hasler Road is a publicly accessible space and it is advised that reasonable care and diligence is applied by the users when using the space. It is advisable therefore to avoid it when there are high winds or other conditions that may result in the unexpected failure of trees.
- 6.4 It was evident in various places that some of the trees are suffering because of compaction and damage from machinery. Damage to the trees opens wounds which are potential points of infection and this may affect the overall health of the tree. When working in and around the trees, best arboricultural practices should be applied and damage to the stems or roots avoided. Due to compaction and damage to the ground, it would be advisable to apply a bark mulch in areas under the trees where the grass does not grow due to lack of light.
- The trees surveyed are situated within the site. Most are in a good or moderate condition although T6 (Ash) would benefit from some minor remedial work and an annual inspection of the trees is advised.

Details within this report are considered correct at the time of writing but modifications may need to be made should more information become available.

Adventitious Growth	New growth arising from dormant or new buds directly from main branches/stems or trunks		
Arboriculturist	Person who has, through relevant education, training and experience, gained expertise in the field of trees in relation to construction		
Construction Exclusion Zone	Area based on the root protection area from which access is prohibited for the duration of the project.		
Root Protection Area (m2)	Layout design tool indicating the minimum area around a tree deemed to contain sufficient roots and rooting volume to maintain the trees viability and where the protection of the roots and soil structure is treated as a priority.		
Services	Any above ground or below ground structure or apparatus required for utility provision. E.g. drainage, gas supplies, ground source heat pumps, CCTV and satellite communications.		
Stem	Principal above ground structural components of a tree that supports its branches.		
Tree Protection Plan	Scale drawing informed by descriptive text where necessary, based upon the finalized proposal showing trees for retention and illustrating the tree and landscape protection measures.

Dear Clerk/RFO/Chairman, Tollesbury Parish Council,

Smaller Authorities Audit Appointments (SAAA) is the independent, sector led organisation responsible for the appointment and contract management of external auditors to smaller authorities since the Local Audit and Accountability Act 2014 established new arrangements for the accountability and audit of local public bodies in England. Smaller authorities are those whose gross annual income or expenditure is **less than £6.5 million**.

Under the Local Audit (Smaller Authorities) Regulations 2015, SAAA is responsible for appointing external auditors to all opted-in smaller authorities, for setting the terms of appointment for limited assurance reviews and for managing the contracts with the appointed audit firms.

This communication is to notify you that SAAA has appointed an external auditor to the authority for the 5-year appointing period from 2022-23 until 2026-2, following a procurement exercise to appoint auditors to each contract area from 1 April 2022.

Your current appointed auditor will conclude any outstanding work on the 2021-22 Annual Governance and Accountability Returns and the new appointed auditor (if changed) will be responsible for the arrangements in respect of the 2022-23 AGAR process onwards.

The contact details of your appointed external auditor and fee scales are shown in the appendix to this letter and can also be found on the SAAA website: www.saaa.co.uk.

The audit firms all have previous experience of conducting limited assurance reviews for smaller authorities and have dedicated support personnel. SAAA will monitor the performance of the appointed firms in providing the audit services in terms of quality and compliance with their statutory terms of appointment.

If your authority has any potential conflict of interest relating to the auditor appointment, for instance if a Councillor or close relation is employed by the appointed auditor, you should advise SAAA immediately.

Exempt authorities

Since 2017-18, authorities where the higher of income or expenditure for the financial year was £25,000 or less and who meet all the qualifying criteria have been able to declare themselves as 'exempt' from a limited assurance review by an external auditor. However, all authorities, even if they declare themselves 'exempt', still need to fully complete, agree and publish an annual return (AGAR).

All authorities require an external auditor appointment even if the authority meets the criteria to qualify for exemption, as a Certificate of Exemption is required to be submitted to the external auditor and a named auditor must be in place to deal with questions or objections from local electors about the accounts.

Annual Governance and Accountability Return (AGAR)

The Annual Governance and Accountability Return (AGAR) needs to be completed in accordance with "proper practices" as set out in 'Governance and Accountability for Smaller Authorities in England, a Practitioners' Guide', and then be published in accordance with any applicable Transparency Code.

Annual Governance and Accountability Return forms will be sent out by your appointed auditor electronically at the end of the financial year. It is assumed that your authority is willing and able to accept documents electronically by e-mail; whilst an authority may request paper copies this may incur an administration charge.

Scales of fees for smaller authorities, are based on bands of annual income or expenditure, whichever is the higher. This means that the fees are broadly proportionate to the public funds involved and the ability of each authority to pay.

Table 1 sets out the scales of audit fees for smaller authorities that complete their AGAR fully and accurately within the required timescales and provide the necessary supporting information and any explanations sought.

Authorities with neither income nor expenditure exceeding £200,000 will be subject to basic limited assurance audit review. Authorities with either income or expenditure exceeding £200,000 will be subject to intermediate limited assurance audit review.

Note: An authority with neither income nor expenditure exceeding £25,000 that is **not** able to certify that it is an exempt authority as it does not meet the qualifying criteria, or if the authority wishes to have a limited assurance review by the external auditor, then the fee payable is £210.

Reminder letters

Where the auditor is required to send a reminder to any authority that has failed to submit either an AGAR or Certificate of Exemption to the external auditor by the statutory submission deadline will be charged £40 + VAT for each reminder.

Additional work and variations to the scale fees

If an active authority fails either to submit its Annual Return to the supplier for review by 30 September or (if it is an exempt authority) to provide a certificate of exemption, the supplier will consider issuing a public interest report, the cost of which will be payable by the authority pertaining to the fee income band of that authority as in Table 1 (above).

Extra fees may also be charged in other circumstances, for example where auditors are required to:

- consider objections to the accounts from local electors, from the point at which the auditor accepts the objection as valid;
- exercise special powers in relation to the review, such as issuing a report in the public interest; or
- undertake any special investigations, such as those arising from disclosures under the Public Interest Disclosure Act 1998.

Extra fees will be calculated and charged according to the work required, subject to the maximum hourly rates set out in Table 2 below.

Dear Michelle,

You may be aware that a growing number of Essex Parish Councils are campaigning to make 20 mph the default speed limit where people and motor vehicles mix, with 30 mph being an exception.

These Parish Councils have started their campaigns with the support of 20's Plenty for Us, a not-for-profit organisation which campaigns to make cities, towns and villages better places to be.

We are now trying to contact those Parish Councils that are not yet involved to ensure that everyone has an opportunity to participate in this Essex-wide initiative. Could you therefore please bring this email to the attention of your councillors.

There is increasing evidence that residents (and voters) want a 20 mph default speed limit. They are fed up with intimidatory and anti-social driving, air and noise pollution and in particular they are concerned for their own safety and that of their families.

There is now a considerable amount of research showing that the introduction of 20 mph limits can be low cost and bring wide benefits, including fewer road casualties, less air and noise pollution, increased walking and cycling. Not least, 20 mph limits help to make communities better places to be.

At present, Essex County Council's process for introducing 20 mph limits is expensive, slow, ad-hoc and village-by-village. We are asking them to change their speed management policy to make 20mph affordable for local communities.

Essex Police have indicated that they would not want to enforce 20 mph limits. However, if 20 mph limits are widely adopted, they will clearly have to be part of the change. In the meantime, evidence suggests that this is not a particular issue since the imposition of 20 mph limits causes motorists voluntarily to reduce their speeds by up to 8 mph.

20'S PLENTY FOR ESSEX CAMPAIGN

The objective of the campaign is to make 20 mph the default speed limit where people and motor vehicles mix, with 30 mph being an exception.

The campaign has drawn on the research of "20's Plenty for Us", a not-for-profit organisation which campaigns to make cities, towns and villages better places to be, and the shared ideas and suggestions of over 120 Essex Parish Councillors.

The benefits of achieving our objective are

- to improve the quality of life in the communities of Essex which are currently blighted by fast moving traffic.
- to make communities safer by minimising the risk of road accidents.
- to contribute to climate change goals by reducing pollution.
- to ensure that the safety and comfort of people in communities takes precedence over the (often insignificant) time saved for people driving through them.

Proposed Actions for Parish Councils

The plan is to approach the challenge as groups of collaborating Parish Councils and individual councils are therefore requested to:

- communicate benefits of 20mph to parishioners:

Proposals for the implementation of the plan

• Base programme on the low-cost, whole-community "wide-area" approach as adopted in Scottish Borders, Oxfordshire, Cornwall.

(see https://www.20splenty.org/universal_demand_for_20 and https://www.scotborders.gov.uk/news/article/4202/permanent 20mph plans approved).

- 20mph speed limit everywhere where people mix with cars and not linked to road status in "roads hierarchy", PR1, PR2 etc.
- Adopt 20mph throughout Essex instead of 30mph as the default speed limit where people and motor vehicles mix, with higher limits the exception not the rule.
- Create a uniform and consistent speed-limit practice across Essex so that it is simple and consistent for drivers.
- Cluster communities together to seek implementation in groups, such as contiguous communities in an area bounded by main roads.
- Road signs only, low-cost installation.
 - > Starting assumption that no civil engineering required; possibly small amount if it proved appropriate but not part of the main programme.
 - There is no need to delay the process or introduce the cost of additional data collection: adequate data is available from existing programmes elsewhere in UK.

Setting 20mph as the default speed limit in towns and villages in Essex

[xxxx] Parish Council requests Essex County Council to adopt 20mph as the default speed limit for urban and village roads in the county. A higher limit can be set as an exception, where there is evidence that it will be safe for pedestrians and cyclists. Regarded as global best practice, the UK government committed itself to 20mph speed limits by signing the 2020 Stockholm Declaration.

Vehicle size has been slowly increasing as carmakers build in more safety and comfort for occupants, so people drive faster without realising.

Stopping distance at 20mph is about half compared to 30mph. Road accidents lead to fewer serious injuries for occupants but not pedestrians. Harm from being hit by a car is proportional to square of speed, so speed has bigger impact than even size of car.

The benefits of 20mph are clear: better for children, better for the elderly, better for pedestrians, better for cyclists and better for disabled. 20mph reduces road casualties and emissions, makes it more likely that people will walk or cycle and has almost no effect on journey times for those in motor vehicles.

20mph is popular. In survey after survey, around 7 in 10 people say they support 20mph speed limits. 28m people in the UK live in local authorities that have committed to a 20mph speed limit on most urban and village roads. Essex is rapidly becoming an outlier among Highways Authorities by endorsing speeds of 50% higher on most built-up roads.

Even where Essex County Council considers a 20mph scheme, its recommendation of high-cost engineering solutions effectively prevents many Parish Councils from implementing 20mph. A signed-only wide-area scheme combined with education is easier and better for everyone: cheaper for ECC and for communities, is more effective and doesn't impact emergency services.

We ask that you work with other decision makers and officers in Essex to set an authority-wide default 20mph limit for urban and rural community roads and make it easier for communities like ours to secure a speed limit of 20mph.

We also ask Essex County Council to write to the UK National Government and request that 20mph be made the national default speed on restricted roads, with 30mph as the exception where warranted.

Dear Councillors and Parish Clerk,

We recently attended the online meeting facilitated by EALC to discuss the 20's Plenty campaign in Essex. Over forty parish councils from around Essex were represented and the overriding feeling was that vehicles travelling too fast for the environment was a problem that affected all areas and was a frequent serious concern of parishioners.

It was accepted that achieving a 20mph speed limit in individual villages is very difficult, time-consuming and virtually unachievable. This campaign is asking parishes across Essex to contact Essex County Council asking for a change in the current policy of 30mph minimum, adopt a new "wide area approach" and implement a 20mph limit across the whole county "where people and motor vehicles mix".

If successful, the obvious benefits would be a safer and calmer environment for motorists and pedestrians and reduced air and noise pollution.

It is thought a more powerful argument would be clusters of communities acting together to seek implementation in groups, e.g. all contiguous communities within an area bounded by main roads - hence us contacting you.

If you wanted to support this campaign, your Parish Council could adopt a motion stating "We would like a 20mph speed limit" and write to Essex County Council requesting them to adopt 20mph as the default speed limit for urban and village areas roads in the county.
