

Proposal to improve and restore the habitat condition of the marshes for a wide range of internationally important wintering wildfowl and locally important breeding waders and other species. RSPB will create 7,200 square metres of new scrapes (seasonally flooded wetland features), create 3 new islands approximately 120 square metres in size, excavate 610 metres of new foot drains, re-profile 1035 metres of existing foot drain, create 500 metres of bunds across a semi-improved grassland field, and repair and renovate 12 historical but degraded crossing points found in the ancient marshes. There is no change of use associated with this proposal, the site will be managed in the same way and for the same purpose after the proposed habitat improvements.
